#### CONTRIBUTORS TO THIS NUMBER.

- George W. Kirchwey is Professor of Law and Dean of the School of Law in Columbia University, Director of the New York (State) Prison Association, Chairman of the New York State Society of Criminal Law and Criminology. He is author of "Readings in the Law of Real\_Property," 1900; "Select Cases and\_Other Authorities on the Law of Mortgages," 1901; he was Editor of the Department of Law of the New International Encyclopedia, 1902-04; contributor to legal and other periodicals; Chairman of the Department of Jurisprudence International Convention of Arts and Sciences, 1904.
- Arthur McDonald, graduated from the University of Rochester in 1879 and studied law in his father's office for about a year. He then studied theology at Princeton and Union seminaries, graduating from the latter institution in 1883. He then studied philosophy, metaphysics and religion at Harvard. He was appointed "Fellow in Psychology" at Johns Hopkins Unuiversity in 1885. Subsequently he spent four years in continental universities (Berlin, Leipzig, Paris and Zurich), taking a full medical course. At Leipzig he pursued psycho-physics in Wundt's laboratory. At Paris and Zurich he studied experimental and clinical medicine, including nervous diseases and insanity and hypnotism under Charcot. On returning to America he was made Docent in Criminology at Clark University, and later became specialist in education as related to abnormality in the Bureau of Education at Washington, D. C., from 1892 to 1893. Since that time he has been engaged in patho-social studies. His publications include: "Abnormal Man," being essays on education and crime, criminal sociology, criminal hypnotism, alcoholism, insanity and genius, with digest of literature and a bibliography (Washington, 1893), etc.
- Edwin R. Keedy is Professor of Law at Northwestern University. He is a graduate of Franklin and Marshall College and the Harvard Law School. He was the first Secretary of the American Institute of Criminal Law and Criminology, and is now the Secretary of the American branch of the International Union of Criminal Law. He was a member of the commission which investigated and reported upon the criminal procedure of England, and is the author of a number of articles on criminal law and procedure.
- Morton Prince is Professor of Neurology in Tufts College Medical School, and Editor of the Journal of Abnormal Psychology. He is author of "Nature of Mind and Human Automatism," 1885; "Dissociation of a Personality," 1906, etc. He has collaborated in the production of "Nervous Diseases by American Authors," "American System of Practical Medicine." and "International System of Electro-Therapeutics."
- Gino C. Speranza, Counsel to the Consul-General of Italy at New York; appointed by Governor Hughes Member Commission of Immigration State of New York, 1908-9. Law Committee Prison Association of New York; Director of Investigation, Bureau of Consulate-General of Italy at New York; some time Special Agent Royal Italian Embassy at Washington for the investigation of labor camps. Delegate to the Colonial Congress at Rome (1911) (Division of Legal Aid to Italian Immigrants); contributor on law and immigration to various magazines and reviews.
- Grace Abbott, M. A., University of Chicago. During the past four years resident at Hull House and Director of the Immigrants' Protective League; anthor of numerous articles on immigration and labor legislation in the American Journal of Sociology, and The Survey.
- John Koren, Expert Special Agent of the United States Bureau of the Census in charge of the investigation of delinquents, defectives, etc., and editor of the publications of the American Statistical Association; author of "Economic Aspect of the Liquor Problem," "The Liquor Problem in its Legislative Aspects," and various bulletins.
