power or forced labor has no lasting part in present day society. Dr. Comfort finally urges the last possible incentive, since it is too late for revolution, that of an "affirmative one-ness of human beings" through a program of mutual aid. He maintains, as Peter Kropotkin, that we have human nature on our side. The essential one-ness of all people in time will create human bonds of love that will survive the vicissitudes of time. The author of this book goes beyond the theoretical programs established to date in much of the political sociology in the United States. Readers may disagree with Dr. Comfort but his realistic analysis is not "without honor."
